

Filed Formal Charges

The Texas Board of Nurse Examiners filed Formal Charges against the following nurses for fraudulently obtaining educational credentials. The Board is authorized to file Formal Charges against a nurse if probable cause exists that the nurse has committed an act listed in Tex. Occ. Code §301.452(b) or that violates other law. See Tex. Occ. Code §301.458. Further, Formal Charges are publicly available. See Tex. Occ. Code §301.466(b). Please note that Formal Charges are not a final disciplinary action, and a nurse is permitted to work, as a nurse, while Formal Charges are pending.
